- -Should home occupations be permitted use in the LR district like all other districts. Striker made a motion to modify our LR Ordinance to state:

add section 6. Home Occupations, except as noted in section 3.14 Cumings Supported

-LR dwelling floor area, are single and multi-story amounts backwards.

Cumings made motion to change LR 19.03 schedule of the LR District regulations Ground floor square footage for a Single story to read 750 square feet Ground floor square footage for a Multi-story to read 600 square feet Striker Second

-Accessory building setbacks, is there inconsistency between Ch3 and Ch6

Striker made a motion to section 3.11 sub sec B to read:

Accessory Buildings shall be permitted within the A-R, R-R, S-R, L-R, and M-R Districts or with any residential use provided that the following restrictions are met:

-Manufactured homes, discuss width and age requirements.

Commissioners discussed width and age requirements. No further decisions made.

-Tiny homes project

Mr. Mau Spoke to the commission and presented examples and a rough sketch of his proposed tiny home/duplex development on Fitzner Rd and M46.

Commissioners asked questions on the specifics of the project.

Mr Mau asked what he could do to move forward, he was advised that he would have to make splits and ask for a variance for minimum sq ft.

#### Short-term Rentals:

Commission discussed the current draft and mentioned a change.

The commissioners recommended a yearly \$50 permit due in January every year to the town-ship zoning administrator.

Striker made a motion to submit the Short Term rental Ordinance and application to the township board with a change.
