They will be able to verify what they would like and where they think it should be. By walking the proposed area, it will help them determine if there are options available in areas that may need adjusting. The projected plan will then be presented to Village Council and Cato Township.

The crack sealing on the streets was completed today.

The county will be partnering with the Village on putting in culverts, ditching, and reclaiming the shoulders on Airport Rd.
