RESOLUTION TO ADOPT 2025-2026 BUDGET RESOLUTION AND GENERAL APPROPRIATIONS ACT

At a regular meeting of the Cato Township Board held at the Township Community Center on June 9, 2025, 6:00 pm.

The following resolution was made by <u>Clark Hubbard</u>and seconded by <u>Behrenwald</u>

WHEREAS, the Uniform Budgeting and Accounting Act, Public Act 2 of 1968, as amended, requires that the Township adopt an annual budget, after public hearing; and

WHEREAS, the Township Board has convened a public hearing on the proposed Township budget for the fiscal year commencing July 1, 2025, after publication of public notice as required by law; and;

WHEREAS, the published notice of the Township Board public hearing on the annual budget stated that the Township property tax millage rate proposed to be levied to support the proposed budget would be a subject of the budget hearing; and

WHEREAS, the Township Board has considered the proposed annual budget for the abovestated fiscal year, has considered comments thereon made at the public hearing and has otherwise considered the budget and the tentative property tax rate for 2025.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Township Board hereby adopts the Cato Township budget for the fiscal year commencing July 1, 2025 and ending June 30, 2026.
- 2. The Township Board shall cause to be levied and collected general property tax on all real and personal property within the Township upon the property tax assessment roll, except property exempt from taxation, at the rate indicated below, or such adjusted or reduced millage amount as may be required by law:

Allocated operating millage - 0.7406 mill Voted Fire Millage 0.9609 mill Total Rate 1.7015 mill

3. The Township property tax rate indicated above shall be subject to final determination by the Township Board, following any required Headlee amendment reduction or such other adjustment as may be required or authorized by law.

4. Township expenditures pursuant to the annual budget, the amendment of the budget, transfer of funds thereunder and other matters pertaining to financial operations pursuant to the budget shall be subject to the applicable provisions of the Uniform Budgeting and Accounting Act.
