### Water & Sewer Connection Fees

Water Connection Fees	
<p>3/4", 1", 2", 3", 4", or 6" Line where water main is in the ROW on the same side of the street where the new service is needed, called a short run.</p>	<p>\$1,000 (includes Village labor and equipment costs, tap of the main, cost of water line from main to the curb stop on right of way edge, and application fee.) Property owner is responsible for cost and installation of the following: installation of the water line from the curb stop to the structure, corporation stop, curb stop, riser and box, meter, meter valves, horn, saddle, radio read unit, directional boring, remote, back flow prevention, and street restoration if there is any.</p>

3/4", 1", 2", 3', 4", or 6" Line where the water main is in the ROW on the opposite side of the street where the new service is needed, called a long run.	\$1,300 (includes Village labor and equipment costs, tap of the main, cost of water line from main to the curb stop on right of way edge, and application fee.) Property owner is responsible for cost and installation of the following: installation of the water line from the main to the structure, water line from curb stop to structure, corporation stop, curb stop, riser and box, meter, meter valves, horn, saddle, radio read unit, directional boring, remote, back flow prevention, and street restoration if there is any.
Any specialized water line that does not conform to the short or long run descriptions above.	Property owner is responsible for all time and material costs incurred by Village along with all material and installation costs for the project.
Replacement of an existing Water Service.	There is a \$50.00 fee for this. The property owner is required to obtain a new permit and follow the same installation criteria that a new service would and our DPW will be out to oversee the process.
Replacement or secondary Water Meter	Property owner is responsible for meter, horn, valves, back flow prevention at current pricing and installation.
New Water Connection Application Fee	\$50.00
<b>Sewer Connection Fees</b>	
Sewer lateral	\$2,000 Property owner is responsible to run the lateral from the property line at the edge of the ROW into the structure. The Village will run it and tap into the sewer main. This also includes the application fee.
Replacement of an existing Sewer Service	There is a \$50.00 fee for this. The property owner is required to obtain a new permit and follow the same installation criteria that a new service would and our DPW will be out to oversee the process.
New Sewer Connection Application Fee	\$100.00
