Pictures of the units that would be placed at Tamarack Meadows were presented. The Brownfield Authority came up with a housing capture to help developers with reclaiming contaminated sites. Under this same program they are offering an incentive to developers to build homes that will allow them to capture tax. This would allow Redstone to create a tax

capture to lower tax payments. This is a 28-year plan that helps the developer recoup some cost. Once there is approval from the Village Council, it goes to the County Brownfield Authority.

This is a long-term vision for our community.
