

VILLAGE OF LAKEVIEW
REGULAR COUNCIL MEETING MINUTES
June 8, 2021

President Case called the meeting to order at 7:00 p.m.

Members Present: Steve Case, Dominic Trevino, Emily Griffith, Lane Leppink, Kate Behrenwald and Greg Saxton.

Members Absent: Chris Fryover

Also Present: Manager & Chief, Darin Dood, Lieutenant Russell, Brian Bucholtz and Melissa King.

AGENDA APPROVAL: Saxton moved and Griffith seconded to approve the agenda as presented. Motion carried.

PUBLIC COMMENTS: None

STANDING ITEMS

Behrenwald moved and Trevino seconded to approve the regular meeting minutes from May 11, 2021 as presented. Motion carried.

Griffith moved and Leppink seconded to approve the Council-Planning Commission-Zoning Board of Appeals meeting minutes from May 26, 2021. Motion carried.

Saxton moved and Behrenwald seconded to approve the April bills in the amount of \$198,687.65 as presented. Manager Dood explained an ammunition purchase. Every year the Lakeview Police Department is given 302 monies from MCOLES (Michigan Commission on Law Enforcement Standards). This money is required to be used for training. Ammunition is an allowable expense. The cost of Well 4 came in at what we expected. Motion carried.

REPORTS

Lieutenant Russell was asked about civil infractions and what is involved in a liquor inspection. He explained what constitutes a civil infraction. It isn't just speeding tickets; it can be equipment violations, accidents, etc. He explained that there are a variety of things that constitute a liquor inspection. They check to make sure the businesses are compliant with their licensing, are the licenses displayed, are they checking ID's etc. Manager Dood explained that annually we need to account to the State of Michigan on our Liquor Inspections. We receive funding for these inspections.

Manager Dood also added that Officer Hansen has taken a position with another County and Officer Kelley will be stepping into the open position.

DPW Supervisor Bucholtz did not add to his written report.

Manager Dood and Brian Bucholtz answered questions for OIC Smith who was not present. It was mentioned the drain near 137 Washington has a terrible smell. There will be a vac truck in town soon and we will have them check the situation out. Brian added the sewer pump has been repaired and back in business.

Manager Dood added that EGLE has accepted our written plan and is going to allow us to continue to monitor the Sewer Lagoons. We also have been awarded the DWAM grant for roughly \$185,000. This will verify Lead and Copper lines and we will be able to get started in the next few weeks with that project. Summerfest is going to be June 17th - 19th. The Summerfest committee will notify the downtown businesses and residents about street closures. The downtown area will be closed off for the carnival. The Ski Show is taking place this weekend and we are very excited about this event. Steve Charnley and Dean Gilbert have put together a music event for Wednesday the 23rd at Lakeside Park.

New Business

Airport Fuel

Peterson Oil has supplied the Avgas to the airport for many years. Peterson has recently sold to Corrigan. Corrigan has decided not to continue the delivery of avgas to our airport but are willing to sell us the tanks and card reader system.

Saxton moved and Trevino seconded to allow the Village Manager to purchase the 3 fuel tanks and card reader system from Peterson Oil/Corrigan for \$1,800 and to start getting fuel delivered to the airport. Motion carried.

Appointment

Steve Case has resigned from his position as Village President from the Village of Lakeview. Trevino moved and Saxton seconded to accept Steve Case's resignation as Village President.

Motion carried.

Resolution

Trevino moved and Behrenwald seconded to adjourn meeting at 7:49 PM. Motion carried.
