Lobert moved and Lund seconded to approve the bills in the amount of \$ 54,413.44, as presented. Motion carried.

Stacey Roberts and Jessica Wright, representing Hough-Pontius VFW Post, presented an American and a POW-MIA Flag.

Gary Nestle, Licensed Operator for Wastewater Treatment Plant, presented on Water/Sewer facilities for the Village of Lakeview.

Police Report – Chief Dood added to his written report regarding blight.

DPW – Village Manager Gallagher reported for the DPW Department. The Village will be reimbursed for the work done near the recycling bins at North Street.

Village Manager, Shay Gallagher, Village Manager, did not add to his written report.

Stacey Roberts, Commander of the Hough-Pontius Post, presented information for Memorial Day. There will be a Memorial Day service at Cato Cemetery at 9:00 a.m., followed by a parade and a 10:30 a.m. service at Lakeview Cemetery. Other activities include food trucks and live music. Lobert moved and Fryover seconded to approve the beer tent and to approve the location in front of Bollinger's Parking Lot. Motion carried.

Village Manager Gallagher presented a Compensation Time Policy.

Lund moved and Fryover seconded to accept the Dixon Engineering proposal at a cost of \$49,890 for the Water Tower painting award. Motion carried.

Lobert moved and Trevino seconded to approve Dixon Engineering's proposed contract to be the Project Administrator and provide direction and all needed paint inspection services at a cost of \$9,950.00. Motion carried.

Lund moved and Lobert seconded to add Pickle Dock Drive to the Act 51 map as requested by MDOT. Motion carried

Lobert moved and Trevino seconded to approve the adoption of the Accident Prevention Policy as presented. Motion carried.

Fryover moved and Lobert seconded to approve the spending of \$18,045.42, as the Village's share for the Police Cruiser purchase. Motion carried.
