

ORDINANCE 92-2

AN ORDINANCE AUTHORIZING COMPENSATION FOR VILLAGE OFFICERS AND TRUSTEES ATTENDING REGULAR MEETINGS OF THE VILLAGE COUNCIL OF THE VILLAGE OF LAKEVIEW.

THE VILLAGE OF LAKEVIEW ORDAINS:

Section 1. PURPOSE. It is the purpose of this Ordinance to provide for the compensation of elected or duly appointed officers and trustees of the Village of Lakeview during the officer's or trustee's term in office for attendance during regular meetings of the Village Council.

Section 2. COMPENSATION.

A. The president of the Village Council of the Village of Lakeview shall be paid the sum of \$31.25 for each regular meeting attended.

B. Each member of the Village Council of the Village of Lakeview, other than president, shall be paid the sum of \$25.00 for each regular meeting attended.

Section 3. PAYMENT. Payment for compensation shall be made within 30 days following each regular meeting attended. All payments shall be made out of the general fund of the Village of Lakeview.

Section 4. EFFECTIVE DATE: The effective date of Ordinance Number 92-2 shall be May 11, 1992.

ORDINANCE 00-1

AN ORDINANCE TO AMEND ORDINANCE 92-2 AUTHORIZING COMPENSATION FOR VILLAGE OFFICERS AND TRUSTEES ATTENDING REGULAR MEETINGS OF THE VILLAGE COUNCIL OF THE VILLAGE OF LAKEVIEW. THE VILLAGE OF LAKEVIEW ORDAINS:

Section 1. Amendment of Section 1, Ordinance 92-2. Section 1 of Ordinance 92.2 is hereby amended to read as follows.

Section 1. Purpose.

It is the purpose of this Ordinance to provide for the compensation of elected or duly appointed officers and trustees of the Village of Lakeview during the officer's or trustee's term in office for attendance during regular meetings of the Village Council and Council Committee meetings.

Section 2. Amendment of Section 1, Ordinance 92-2. Section 2 of Ordinance 92.2 is hereby amended to read as follows.

Section 2. Compensation.

A. The president of the Village Council of the Village of Lakeview shall be paid the sum of \$75.00 for each regular meeting attended.

B. Each member of the Village Council of the Village of Lakeview, other than the president, shall be paid the sum of \$50.00 for each regular meeting attended.

C. Each member of the Village Council of the Village of Lakeview, other than the president, shall be paid the sum of \$25.00 for each Council Committee meeting attended.

Section 3. Effective Date. This ordinance shall take effect twenty (20) days after its adoption or upon its publication, whichever occurs later.
