REGULAR COUNCIL MINUTES
February 8, 2016**

AGENDA APPROVAL –Lobert moved and Trevino seconded to approve the agenda as amended. Motion carried.

PUBLIC COMMENTS:

John and Kathy Grawburg reported on the status of a Veterans Memorial. There is a Committee in place working on the details. They asked for continued Village Council support.

Minutes – Lund moved and Case seconded to approve the minutes of January 11, 2016, as presented. Motion carried.

Bills – Lobert moved and Collard seconded to approve the bills in the amount of \$43,603.50, as presented. Motion carried.

Police Report – Chief Dood did not have any additional information to add to his written report.

DPW – Mike Vellanti, DPW Supervisor, added to his written report and stated the process for sidewalk snow removal is going well. Appreciation was given to Lakeview Schools for the salt spreader.

Airport – Mike Matthews, Airport Manager, reported on the need for lighting in back parking lot of the Airport Terminal Building.

Village Manager – Jake Eckholm noted there is a new format with a code system for agenda items. He reported water and sewer has been installed for Pickle Dock Drive, with the final

walk-through scheduled for this week. A special Council Meeting is scheduled for February 24th to work on the budget. Rowe Professionals will be at the March Council meeting to present findings from their recent Feasibility Study.

Village Manager Eckholm presented results for the Single Hauler Solid Waste Community Feedback Survey Data Report. He noted 37 surveys were returned.

Lund moved and Collard seconded to table the Single Hauler Solid Waste issue.
