Cato Township Residents: Ron & Patricia Buckholtz:

Mr. Buckholtz spoke about concerns regarding the townships lack of clarity/regulation within the zoning ordinances (Section 3.28) on parking/camping on vacant/unimproved Lakefront lots. Mr. Buckholtz asked that the planning commission take immediate action on the issue discussed.

Old Business:

Lakefront-Residential Ordinance:

Morrow read emails from township residents regarding camping and sheds on lakefront lots:

Commissioners discussed issues regarding camping on vacant/unimproved lakefront lots.

Attorney discussed what other township ordinance's regulate.

- Temporary use for camping, accessory use not permanent.
- Potential for permit needed for camping on vacant/undeveloped lot.
- Could be a Health Department Issue with septic concern.
- Building Department permit

Kelsey- advised Douglass Township no camping on lake residential

Further discussion about Lakefront-Residential Ordinance.

Attorney to advise on recommended changes for Lakefront-Residential at next meeting.

New Business:

Amend Zoning Ordinance, Regulate Solar Energy Systems

Amend Zoning Ordinance, Regulate Wind Energy Systems

-Attorney discussed how the amendments would only take effect if PA 233 does go into effect for Wind and Solar.

-Attorney also talked about recommended acreage, 300-500 acres for all energy systems allowed within the township.

-Commissioner Stryker advised he will abstain from the vote due to moral conflicts because of the State taking control

Battery Energy Storage Ordinance

-Attorney Provided an ordinance for Battery Energy Storage Ordinance

-Ordinance was written to follow the current township ordinances while following the new state guidelines.

Amendments for Wind and Solar Ordinances, new Ordinance for Battery Storage will be presented at the public hearing and voted on at next Special Meeting October 9, 2024

Chairman Morrow advised he will not be renewing his Seat.

Winfield Township letter advised that they are revising their master plan and invited the commission cooperation
